 - ❖ 85% of organizations report having lost revenue after an incident (Sophos Data Breach Report)

The Costly Reality:

- Cybercrime damage predicted to hit **\$10.5T** annually by 2025
- Growing sophistication of attacks
 - Social engineering
 - Ransomware
 - Data breaches
- Average cost of a data breach is **\$4.45M** in 2023
